6. Old Business

A. Building Department Update Discussion – Tracy Kallek Building official READ A PREPARED STATEMENT SHOWING A STEADY DECLINE IN BUILDING DEPARTMENT FUNDS AND STATED THAT WITH THE CURRENT FIXED FEE SCHEDULE EVENTUALLY THE MONEY WOULD RUN OUT AND THE GENERAL FUND WOUD HAVE TO SUBSIDISE THE BUILDING DEPARTMENT WHICH HE FELT WAS UNFAIR TO TAX PAYERS- presented an updated document to increase fees for the building department to be more in line with other jurisdictions in the state. He proposed eliminating the \$150.00 application fee and replacing it with a \$75.00 nonrefundable application fee that would go to the township. He presented AN EXCEL DOCUMENT SHOWING 3 different percentages USING THE INTERNATIONAL



CODE COUNCIL HOME VALUATION METHOD OF PERMIT FEE STRUCTURING and compared them to an example using the current FIXED FEE pricing system. He suggested using the 3/4% multiplier WHICH IS THE CURRENT INDUSTRYSTANDARD, HE CITED SEVERAL OTHER LOCAL JURISDICTIONS USING THE ICC METHOD. The building official would get 75% and the township 25% of the fees. Clerk said that she did not think the township should raise fees at this time with the cost of everything going up this would be an additional burden. Trustee Dudek said I THINK THE TIMING IS WRONG. he did not think this was the right time to increase fees. Kallek presented a letter saying at the current trend the fund balance was in a steady decline. Clerk said that currently the rent being charged was \$1500.00 per month which totals \$18,000. per year and was started to offset the payroll of the deputy clerk, who was doing the building department clerical work. Currently we have a building department clerk who is paid out of the building department so the \$1500 rent is not really necessary and could be reduced. Dudek said if we reduced the rent, it would bring the fund balance back up. AFTER TRYING OUT DIFFERENT PERCENTAGES IT WAS DETERMINED THAT AT 1/2%, LOW PRICED, SMALL SQUARE FOOTAGE HOME PERMITS WOULD REMAIN APPROXIMATELY THE SAME AND THAT LARGER, MORE EXPENSIVE HOME PERMITS WOULD COST SOMEWHAT MORE. IT WAS NOTED THAT THE CURRENT FIXED PRICE SCHEDULE HAS BEEN STATIC SINCE 2014. Motion Christy Support Kielman to adopt ICC fee schedule at $\frac{1}{2}$ % with 75% paid to TK Inspections and 25% to township, charge \$75.00 application fee and \$75.00 reinspection fee PLUS PLAN REVIEW. To take effect the first day of the following month once the FINAL WRITTEN fee schedule AND AMENDED CONTRACT is approved by the township board. Christy-yes, Dudek-no, Duncan-yes, Kielman-yes, Biringerno. Motion Carried.


